

GUIDELINES

The following paperwork is required in order to complete application process:

Applicant: Income requirements: 40 x the monthly rent

Employee

- 1. Completed Bold New York "RESIDENTIAL APARTMENT APPLICATION".
- 2. First two pages of your most recent tax return.
- 3. Current employment letter stating position held and yearly salary. Letter must be printed on a company letter head and signed.
- 4. 2 Current Bank statement (checking, savings, portfolio, money market).
- 5. 2 Most Recent Pay Stubs.
- 6. Copy of valid state photo id. Current passport & or driving license.
- 7. Landlord Reference Letter.

Self Employed

- 1. Completed Bold New York "RESIDENTIAL APARTMENT APPLICATION".
- 2. CPA letter confirming your previous years income.
- 3. First two pages of your most recent tax return.
- 4. 2 Current Bank statement (checking, savings, portfolio, money market).
- 5. Copy of valid state photo id. Current passport & or driving license.
- 6. Landlord Reference Letter.

Students - Guarantor required

- 1. Current Bank statements (checking and savings)*.
- 2. School letter stating enrollment*.
- 3. Landlord reference letter*.
- 4. Copy of valid state photo id. Legible passport & or driving license*.
- 5. Landlord Reference Letter.

Guarantor: If requested must be U.S. Citizen. Income requirements: 80-100 \boldsymbol{x} monthly rent.

Employee

- 1. Completed Bold New York "RESIDENTIAL APARTMENT APPLICATION".
- 2. First two pages of your most recent tax return.
- 3. Current employment letter stating position held and yearly salary. Letter must be printed on a company letter head and signed.
- 4. 2 Current bank statements (check, savings, money market).
- 5. 2 Most recent pay stubs.
- 6. Copy of valid state photo I.D. Current passport and/or drivers license.

Self Employed

- 1. Completed Bold New York "RESIDENTIAL APARTMENT APPLICATION".
- 2. CPA letter confirming your previous years income.
- 3. First two pages of your most recent tax return.
- 4. 1 Current Bank statement (checking, savings, portfolio, money market).
- 5. Copy of valid state photo id. Current passport & or driving license.
